



# HOCKEY CANADA MINOR / FEMALE MINIMUM SUSPENSIONS

Updated: June 2022



The following minimum suspensions are not to be reduced; Members, Association and Leagues may strengthen any of the listed offences at their discretion.

These guidelines represent all levels of Minor hockey and all divisions of Female hockey.

Accumulation Sanctions - Player	
Any player receiving 2 Majors in same season for any of the above infractions	2 games
Any player receiving 3 Majors in same season for any of the above infractions	4 games
Any player receiving 4 Majors in same season for any of the above infractions	Indefinite suspension pending a hearing.
Accumulation Sanctions - Coach	
Any team receiving a combination equaling 3 penalties in the same game from a Major penalty, Match penalty or fighting infraction.	1 game
For a 2nd violation of a team receiving a combination equaling 3 penalties in the same game from a Major penalty, Match penalty or fighting infraction.	3 games
For a 3rd violation of a team receiving a combination equaling 3 penalties in the same game from a Major penalty, Match penalty or fighting infraction.	Indefinite suspension pending a hearing.

7.10(e)	Any player receiving a fighting Major penalty, which is a result of a second or subsequent fight during the same stoppage of play.	2 games
10.4(e)	Player identified as first to leave the players' or penalty bench during a fight or for the purpose of fighting.	3 games

10.4(e)	Coach of a team whose player is identified as first to leave the players' or penalty bench during a fight or for the purpose of fighting.	3 games
10.4(e)	Coach whose player is not identified as the first to leave the players' or penalty bench during an on-ice altercation.	1 game
7.11(a)	<b>Instigator / Aggressor of a Fight</b>	
	First Offense	1 game

7.10(b)	<b>Pre/Post Game Altercations</b>	
	Any player involved where Majors and Game Misconducts are assessed.	2 games
	Coach of team whose players are so penalized.	Indefinite suspension
	Any team involved in a pre or post game brawl.	Indefinite suspension

## OTHER

Rule #	Type	Penalty	Suspension
4.8(c)	Game Misconduct	<p>Any player or team official who is assessed a Game Misconduct penalty in the last 10 minutes of regular playing time, at any time in overtime, or after the conclusion of the game will automatically be suspended for a minimum of the next regular league/play-off game or seven days.</p> <p><i>Note: The 1 game suspension under Rule 4.8(c) is in addition to any suspensions applied under the minimum guidelines.</i></p>	1 game
4.9(b)	Gross Misconduct	<p>Any player or team official who is assessed a Gross Misconduct penalty in the last 10 minutes of regular playing time, at any time in overtime, or after the conclusion of the game will automatically be suspended for a minimum of the next regular league/play-off game or seven days.</p> <p><i>Note: The 1 game suspension under Rule 4.9(b) is in addition to any suspensions applied under the minimum guidelines.</i></p>	1 game
